## **Changing Federal Requirements**

- Recent U.S. Supreme Court cases, Executive Orders, and directives from federal agencies prohibit use of race, color, national origin, sex, religion, etc. as criteria for participation in programs and services.
- Federal grant recipients, including the City, will be required to certify they do not have such programs, even if using non-federal funds for the programs.

#### **Civil Rights**

These federal grant requirements do not currently affect:

- City's Human Relations Ordinance
- ADA Accessibility and Reasonable Accommodations
- Civil Rights Act Unlawful Discrimination
- Fair Housing
- Fair Employment





#### **Penalties for Noncompliance**

- Loss of existing and future federal funds
- City employees subject to individual civil and criminal liability
  - > False Claims Act
- Treble damages against the City

Example:  $$40.6M \times 3 = $121.8M$ 

#### Recommendations

- City Council adopts resolution to suspend Council-approved programs providing a benefit based on race, ethnicity or gender:
  - ✓ Business Equity Ordinance
  - ✓ MWBE requirements in economic development incentive policies
  - ✓ Duties of Diversity & Inclusion Department prescribed in City Code addressing racial, ethnic, and gender disparities
  - ✓ Any other applicable Council-approved programs
- Staff administratively revises other programs as needed.

#### **Support for Small Business**

- Staff to develop more robust Small Business Development
   Program
- Continue to use the following as allowed/required by law:
  - ✓ City's **Local Preference Ordinance** for purchasing with local funds
  - ✓ Historically Underutilized Businesses as required for purchasing with state funds or City funds greater than \$3,000
  - ✓ Disadvantaged Business Enterprises as required for purchasing with federal DOT and EPA funds

19.8% increase in City tax rate

- Single family homestead appraised at \$300,000
- 20% local homestead exemption
- \$240,000 taxable value
